1. Respective responsibilities of the body and the auditor

Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

2. 2016/17 External auditor's report

On the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no other matters have come to our attention giving cause for concern that relevant legislative and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the smaller authority:

The approval date for Section 1 was originally stated to be after the approval date of Section 2 despite both sections being actually approved on the same day. It was due to the Council approving a draft of the accounting statements but then approving the final version with the annual governance statement. The annual return was corrected to show the date Section 2 was finally approved but in future the Council needs to ensure that the approval dates are entered correctly.

The initial bank reconciliation provided did not have the balance relating to the date 31 March 2017. Although there was no change between the balances on the dates provided and 31 March 2017, in future, the Council needs to ensure that all bank balances are stated as on the 31 March of the financial year.

Guidance notes on completing the 2016/17 annual return

1. You must apply proper practices for preparing this annual return. 6. Make sure that the copy of the bank reconciliation which you send to your external auditor with the annual return covers all your bank accounts. The external auditor must be able to agree your bank reconciliation to Box 8 on the accounting statements (Section 2 on page 3).
