#### 223.2 Planning

#### **Applications**

**15/08161/FUL- Mede Cottage, Park Farm Road** -- Erection of 1 x 4 bed detached dwelling

The Parish Council strongly objects on the grounds that this is an over development of the site and will have a considerable dominance and impact and will be visually intrusive on the neighbouring properties.

We feel that the drawings are inadequate and lacking in detail and inspiration with a building which looks like a warehouse and will be totally incongruous in a very pretty residential street of 1930's properties.

We have concerns over the height of the building if the drawings are to scale - compare the 1.8m height of the boundary fence to the eaves.

We have concerns about the proposal to remove the trees on site as these would provide some element of both visual and noise screening.

There are already long standing problems with an overload of the sewage system. Although stated to be a 4 bedroom property this has the potential to be a six bedroomed property or suitable for conversion to flats or a house of multiple occupancy —the latter two options would be totally out of keeping and unacceptable in Park Farm Road and would exacerbate the sewage issue.

The basic drawing shows a garage and one car parked in front of the garage – a four bedroomed property is likely to have more cars than this and although the application states that 4 parking spaces are created we do not see this as being viable when a turning circle will be required to ensure that cars are not reversing out on to the main road.

We cannot see any reference to parking for Mede Cottage who already park one car on Park Farm Road. We can only assume that they will remove the front garden of Mede Cottage to create parking clear of the joint driveway. If this is the proposal then this would totally destroy the street scene and create a very urban appearance in a classic tree lined road.

There are already huge problems caused by the narrow drive at 399 West Wycombe Road. Residents at 399 do not use their property for parking as space for parking and turning is limited. They continually park on Park Farm Road on the junction with the A40 and are constantly reversing out on to Park Farm Road. Extra cars parked on both sides of Park Farm Road will cause difficulties for emergency vehicles and waste recycling vehicles.

The creation of this property will seriously adversely affect the value of the neighbouring properties, in particular The Haven and will be a dominant structure overlooking all the currently very private rear gardens on this side of Park Farm Road.

The Parish Council strongly recommend that this goes to committee with a site visit.

### **Decisions**

**15/07772/FUL - 460 West Wycombe Road** – householder application for erection of two storey side and rear extension and alterations; creation of new hardstanding; access steps and retaining walls to front; new retaining walls and steps to rear garden – permit **15/06148/FUL -6 Beechwood Road, High Wycombe** -Householder application for construction of first floor rear extension – appeal dismissed.

223.3 To consider the WDC Consultation on the Local Plan for Princes Risborough
Whilst West Wycombe Parish Council accepts and understands the need to construct
more residential dwellings in this district we have strong concerns over the increased
amount of traffic which will be created by possible/proposed developments at the Molins
site, Longwick and Princes Risborough on the A4010,all of which will converge at The
Pedestal Roundabout in our parish. This roundabout is the daily walking route for our
primary school children and we have concerns about pedestrian safety. This Parish
Council has been asking Bucks County Council for over 15 years for work to be
undertaken on this dangerous road. It is unlit and does not have a white line painted on
either side of the carriageway; has very little scope for overtaking; is the main blue light
route between Stoke Mandeville and High Wycombe hospitals and it is the main route
from the North of the county to the M40 and M4. Cars are already queueing from The
Red Lion at Bradenham every morning and the proposed increase in traffic volume could
take this queue back to Saunderton.

This Parish Council would like to see:

Methods considered to ameliorate the increase in traffic by enhanced use of the train service and a better bus service.

Creating employment opportunities within the new developments would reduce traffic. Robust ideas from the planning process to reduce car use.

The Parish Council are pleased to have the opportunity on being consulted on this Local Plan and would like to be involved on how the action plan develops.

223.4 To consider placing an order for work at the Pedestal Roundabout verge

Elizabeth Stillman has supplied a price of £309 to extend the planting. We need to have the rear hedge reduced or removed. It was resolved to extend the planting and remove one of the hedge shrubs.

## 223.5 To report any Highways issues including village signage

All non-working street lights have been repaired other than the light above the belisher beacon.

The Clerk produced photos of the current signage. Cllr Timberlake produced some brief initial designs for discussion at the January meeting. Clerk will make contact with Bucks County Council to discuss the possibility of rationalising signs once we have a clear idea of what we believe is necessary.

BCC have stated that the bus routes 40 and 275 will be decided upon by Oxfordshire CC in February and then they will make their decision.

#### 223.6 To consider the fee structure for West Wycombe Burial Ground

It was resolved to increase the erection of memorial and memorial plaque fees to £90 as from 1<sup>st</sup> January.
