CONFIRMATION AND SIGNING OF MINUTES OF THE MAY MEETINGS

The Minutes for the Annual Parish Meeting and the May Parish Council meeting were agreed by those Councillors present and signed by the Chairman.

REPORT ON PROGRESS ON ITEMS IN THE PREVIOUS MINUTES

- A planning application will be submitted based on the papers produced by Cllr Harris who has inspected the burial ground trees – 7 trees to be removed in the avenue, 8 need felling in shelter belt with plans for the future for further felling and under planting.
- 2. Clerk has contacted SWARCO re the MYSID and the unit is now working correctly although currently switched off.
- 3. TVP has carried out some speed checks in the parish.
- 4. The rope around the basket swing has been unravelled the manufacturers are assessing the damage.
- 5. Arrangements are being made for clearing the allotment plot of wood and chippings.
- 6. The allotment padlock was damaged and has been replaced.
- 7. We have had a recurrence of bees on the allotments by the tap but this seems to have been resolved
- 8. Chairman and Clerk attended a 3 hour meeting on BCC's proposals for unitary.
- 9. Annual Report produced and circulated and on website.
- 10. Debris at the bottom of Cutty Alley and Church Lane caused by heavy rain reported to TfB.
- 11. Damaged sett in High Street has been reported to TfB.
- 12. Blocked gullies along Chorley Road have been reported to TfB
- 13. Lighting times at the public toilets have been queried and also a thank you sent to WDC about the good quality of cleaning.
- 14. Clerk has contacted the owners of Gerrard Court to cut their hedge and weed kill the growth coming under the fence; also spoken to West Wycombe Estate about the land beyond Gerrard Court as it needs tidying up all the work was completed within 48 hours.

 The Clerk has spoken to Downley Parish Council who explained their arrangement which is for Downley Dynamos to undertake all the grass maintenance. Their previous rental had been £450pa. It was resolved to increase our rent to £400 per annum as from September 2017.

240.6 To report and discuss any Highways issues

It was resolved to purchase a 45l green dog bin and metal bracket at a cost of £295 to be placed at the bottom of Park Farm Road. County Cllr Hayday will provide funds from his Leaders Fund to purchase the bin and pay for its emptying whilst he is our County Councillor.

Cllr Brown reported the first weeks results of the MYSID unit -2000 vehicles over the speed limit in one week with the highest speed being 97mph. It was resolved that we would ask County Cllr Hayday to see whether the police would install a yellow speed camera. It would cost the Parish Council between £10 - 15,000 to install a narrowing scheme in Chorley Road.

Portway Drive has been jet patched.

The gullies in Chorley Road will be cleaned once Thames Water has repaired the water leaks.
